MCA has been involved in more than just planning conferences and workshops. After unsuccessfully contacting the Board of Professional Counselors to update their website and supervision forms we reached out to Rep. Julie Palakovich-Carr, our Maryland Representative in our main office location. After contacting Rep. Palakovich-Carr's office, the Board did update the forms to reflect the current Governor and other government leaders on official forms.

We were contacted by LCPCM to collaborate on providing feedback to CMS for the proposed physician rules which affects compensation rates to counselors. Many LCPCM and MCA members offered feedback to CMS and we eagerly await the final report. We will have a new liaison with LCPCM and also with MSCA, for school counselors, and we look forward to collaborating on joint ventures in the spring.

We are so proud to host many different workshop offerings, networking and some in person social gatherings, both through MCA and our divisions! If you have a topic of interest or if you want to share your own expertise, please email me!

We are proud to say that after an extensive internal audit, we are confident that we are doing well financially as an organization and look forward to expanding over the next few years. After a slight decrease in membership last July, our current active members are 448, which is close to our average over the last 10 years. Our goal is to increase our membership to 1500 in three years. Please look for a formal end of year report by December on the State of MCA.

MCA wants to be the place for counselors to find professional development, advocacy, leadership training and support as well as a networking community.

We pride ourselves on having a robust, diverse Board, and would welcome new volunteers or board members. We are in need of Treasurers, both for MCA and our Divisions. This is not a role that is done solo or without support, nor do you need to have an accounting background.





How much do ads cost?

Pricing is based on size of the ad per page. A quarter page is \$25, a half page is \$50 and a full page is \$75. For example, if your ad is 2 full pages, your total will be \$150.
